Annual General Meeting – Kingsway Clubrooms, Bellerive Boulevard, Madeley on 15 May 2019

Meeting opened at 7.00pm.

A total of 16 members attended in accordance with the attached signed attendance sheet.

Minutes: The minutes of the previous AGM were read and accepted by the meeting. Acceptance was proposed by William (Jock) Irvine and seconded by Graeme Atkinson.

Business Arising: Nil.

Treasurer's Report:

The Treasurers Report, copy attached, was presented.

Karen Dzodzoz presented her report to the AGM.

The Treasurer reported that the Auditors had reported being pleased with the current financial status of the Club and the methods adopted by way of recording such. Their official Auditors Report for the 2017/2018 Financial Year is to be submitted.

Also tabled were a Profit & Loss Report, Profit & loss Statement, Bank Account Transaction Report and Reconciliation Report. Copies of these documents are attached. The balance as at 30 April 2019 was \$81,327.70.

Presidents' Report:

David Minear presented his report to the AGM.

Specific mention was made of the contributions of Graham Burton, Graeme Quelch, Craig Nylander, Chris Quelch, Allan Hall, Jim DiCarlo, Graeme Atkinson, Michael Ardagh and Keith Atkinson. Their various and extensive service to the WDCC was recorded and best wishes for the future were expressed along with the hope that we would see each one of the outgoing members around the Club next season.

WDCC have now taken control of the Clubrooms. Essentially the Hockey Club will become tenants for their season. This allows us to assume complete control of the Liquor Licence. Our relationship with the Hockey Club is improving and is probably at the best level it has been and is essentially the result of more frequent communication channels.

The start to the season presented significant challenges with the unavailability of the playing wickets. However, the wait was worth it, and the decks continue to improve. Next season will also have challenges as the practice wickets are being replaced and our practice facilities will not be available for the start of the 2019/2020 season.

The future financial status of the Club has been secured with the relationship struck up with the Darts Club which continues to improve. WDCC is well placed financially compared to other WACA member district Clubs.

Thanks, was also expressed to those Committee members remaining for their work in the previous year and for the future.

Generally, the Club is in a very good position and has a very bright future.
